#### Consultation on annual return 2023 concludes

For information

The Charity Commission has <u>published</u> its response to the conclusion of the consultation on the Annual Return 2023. The Commission received 460 responses, with 54% of respondents were acting on behalf of their charity and included both trustees and employees; 38% of respondents were trustees sharing their personal view on the consultation topics.

Overall, the tone of engagement was positive. Early analysis of the feedback received indicates areas requiring further thought to help ensure the Commission gathers data in a way that is straightforward, and relevant to charities regardless of their purpose and the type of work they do.

National Mourning period: guidance for faith and belief groups and places of worship

For information and possibly for action

DLUHC has <u>published</u> guidance for faith and belief groups and places of worship on the National Mourning period, following the death of HM Queen Elizabeth II.

The publication suggests some ways for such groups to play an active role, in line with the wider process of National Mourning, ahead of the State Funeral itself. This document is not intended to be prescriptive or a rulebook. It provides some general guidance and suggestions that places of worship, and faith and belief groups more generally, may wish to consider when making their own plans for services or other events. The guidance covers the following: <a href="Prayer and worship">Prayer and worship</a>; <a href="Areas of mourning and floral displays">Areas of mourning and floral displays</a>; <a href="Books of condolence">Books of condolence</a>; <a href="Religious">Religious</a>, <a href="Community and civic buildings">Community and civic buildings</a>; <a href="Other issues to consider">Other issues to consider</a>; and <a href="Co-ordination with others">Co-ordination with others</a>.

Various denominations published their own prayers and liturgical resources to commemorate Her Majesty:

- Catholic Bishops' Conference of England & Wales: <u>Prayers for the Repose of the Soul of HM Queen</u> Elizabeth II.
- Church in Wales: Service in commemoration of Her Late Majesty Queen Elizabeth II.
- Church of England: *Resources and liturgy on the death of HM The Queen*.
- Church of Scotland: Prayers and worship material for use following the death of the Queen.
- Methodist Church: <u>A prayer vigil on the death of The Sovereign</u>.

# **Energy bills support**

For information and possibly for action

BEIS has <u>published</u> guidance on the energy bills support package that was announced by the Prime Minister.

For consumers, the Energy Price Guarantee will "ensure that a typical household in Great Britain pays an average £2,500 a year on their energy bill, for the next 2 years, from 1 October 2022."

A new six-month scheme for businesses and other non-domestic energy users (including charities and public sector organisations like schools) will be offered support as is being provided for consumers. After this initial six-month scheme, the Government will provide ongoing focused support for vulnerable industries. There will be a review in three months' time to consider where this should be targeted to make sure those most in need get support.

#### **Energy cost survey**

For action

Trevor Cooper, Chair, and Becky Payne, Development Director, of the Historic Religious Buildings Alliance (HRBA) are seeking hard evidence about the likely extra energy costs that will be incurred by

historic churches and other places of worship this winter for its parent organisation, the Heritage Alliance, to present to Government, as follows:

"ENERGY COSTS THIS WINTER

1. We would like to know your energy costs last winter and your best estimate of costs this coming

winter. These are total costs, not price per unit of energy.

2. We would also like to know if at present you foresee or are considering any reduction in your

activities because of increased bills, and any details you can give us.

3. We need to know on whose behalf you are responding, though all information will be anonymised.

That simple information will be very useful in making a case. However, if possible . . . .

4. Please tell anything else you think it would be useful for us to know to present a case to government.

Here are some possibilities, but none of this is essential:

a) whether your building is a cathedral, or in any other way of unusual size or complexity

b) roughly how many people are financial supporters of the building (alternatively, typical

congregational attendance)

c) some idea of the size of your annual income and of your annual surplus (if any)

d) whether you would describe the location of your building as village, small town, suburbs,

urban, city centre - or any other descriptor of location

e) if your building is the only place of worship in the community (this will tend to be in villages

and some small towns), the approximate number of people living in the community

f) anything you might know about local levels of deprivation

g) anything else you want to tell us.

# **SCOTLAND**

Scotland: Programme for Government 2022 to 2023

For information and possibly for action

The Scottish Government has published <u>A stronger and more resilient Scotland: the Programme for Government 2022 to 2023.</u> The Programme for Government sets out the actions that the Scottish Government will take in the coming year and beyond and includes the legislative programme for the parliamentary year.

As part of the Programme, the Scottish Government intends:

- to introduce emergency legislation to protect tenants by freezing rents and imposing a moratorium on evictions until at least 31 March 2023. It will also act to prevent immediate rent increases;
- to publish an energy strategy;
- to publish a consultation on the Heat and Buildings Bill;
- to develop a Housing Bill and a new deal for tenants; and
- to "Increase the transparency and accountability of Scotland's vital charity sector through our Charities (Regulation) Bill"
