The President, George Phillips, introduced this item outlining the main points concerning moving to a CIO, and the changes it will mean.

A referendum had been held among the churches regarding changing to a CIO. There were 29 responses, 27 were in favour with 2 not having an opinion.

It was recognised that some of the wording in the appendices will need refining at the earliest possible opportunity in order to clarify the intended meaning. An example was shown in the Ethical Statements (appendix C) regarding marriage.

No presentation of the statistics was made. Realistically they are only just settling down after the effects of COVID.

Decrease of 143 is less than was anticipated.

A number of churches have been lost, accelerated by not meeting together as result of COVID. As Michael Hedley commented on Monday, we need to look at things positively.

In the Sheffield circuit, the Oughtibridge church has merged with the local parish church. Members of this Church are still listed as union members to allow time to see that this move is successful and allow the trustees to remain eligible. This represents a significant proportion of the decrease in membership. The building is also on the reference deed.

These figures will be in the yearbook once it is published.

A time was set aside for questions and comment after the statistics were seconded. The new national spiritual coordinator role is in part a pre-response to these figures.

"God is not finished with the WRU yet" and "We're stronger together," two lines from Michael Hedley's presentation on Monday night have been key phrases in the work of the Women of Action over the last few years.

16. Safeguarding Report

Report by Mr S Sykes

Safeguarding as ever remains a very important part of our church life, safeguarding should still be on every church meeting agenda to make sure it is kept at the forefront of our minds.

The past year for me has been a much more advisory role for the Union. I have had a lot of changes and challenges to deal with at work in the last year so, I have not been able to spend as much time as I would like on safeguarding, but I have been able to advise a number of churches on different issues that they have had. I am aware that there is still a need for some more safeguarding training within our churches, but I understand that people have limited spare time and there seems to be less people to do more work. I am trying to look at a way of producing a short presentation that churches can use within their church meetings to cover the basics, but condensing safeguarding into a 20-minute presentation is not easy.

It has not been a big year for changes in Safeguarding this year but there are one or two things that have been coming through recently.

Many people will now have heard of FGM (female Genital Mutilation) and the effect it can have on young girls. But a new practice that is only just coming to light in the UK is IOM (Infant Oral Mutilation) unlike FGM which is done due to cultural beliefs, IOM is done more through medical ignorance but can still be just as devastating for a child. In brief IOM is most prominent in Africa but some cases have been seen recently in the UK, USA, France, and Norway. It is when children who are at teething age present with symptoms such as Sickness Fever or Diarrhoea, (usually caused by a simple childhood stomach bug). These children are taken to local healers who misdiagnose and see the emerging teeth buds in the mouth and assume they are Parasitic worms which is a condition that can also present with similar symptoms. The tooth buds are then Gouged out using unsuitable and unsterile tools and usually without any anaesthetic, this results in great pain for the child and possible future complications with mouth deformity and even death in some cases. This is not something I expect many people to come across at present, but it is something just to be aware of.

The education Department updated their keeping children safe document at the end of last year and there have been a few changes that are relevant to us as churches. One of the areas of change is clarifying guidance on Peer on Peer abuse, emphasising that everyone who deals with children and young people should understand the importance of challenging inappropriate behaviour between peers, we should recognise that downplaying certain behaviours as "just banter" or "kids being kids" can lead to a culture of unacceptable behaviour, an unsafe environment for children and a culture that could normalise abuse.

The other main area of concern is around mental health, since the pandemic there seems to be more children and young people presenting with mental health problems. Do we know the signs, do we know what to look out for? Many mental health problems can manifest in behavioural problems and so can be misunderstood. Specific Mental health first aid courses are being delivered throughout the country and this may be something your church may want to look at if you have a number of children and young people using your building and services.

The IICSA published their final report about "Child protection in religious organisations and settings" at the end of last year, This is the independent investigation that has been ongoing for the last few years, it is a lengthy document (230 pages) so I won't read it out to you, you can just read the executive summary (5 pages), but jumping to the recommendations at the end of the report there are 2 main recommendations.

Firstly

All religious organisations should have a child protection policy and supporting procedures, which should include advice and guidance on responding to disclosures of abuse and the needs of victims and survivors. The policy and procedures should be updated regularly, with professional child protection advice, and all organisations should have regular compulsory training for those in leadership positions and those who work with children and young people.

This is something that our churches should already have in place and if not let me know and I can help you in putting things into place.

Secondly

The government should introduce legislation to:

- change the definition of full-time education, and to bring any setting that is the pupil's primary
 place of education within the scope of the definition of a registered educational setting; and
- provide the Office for Standards in Education, Children's Services and Skills (Ofsted) with sufficient powers to examine the quality of child protection when it undertakes inspections of suspected unregistered institutions.

This is designed so that churches that run educational settings do not fall outside the realms of government inspectors, I do not think this one will affect any of our churches, but it is something to bear in mind.

The report also highlights the inconsistencies in organisations with regards to obtaining DBS checks for anyone working with children, it does acknowledge that it can at times be difficult to obtain a DBS check as the guidelines are not always clear about who should have them (the term "supervised activity" is not always understood). If churches have any concerns in this area or are unsure, I am always available to offer advice.

Simon reminded conference that despite the fear it generates in people's minds, Safeguarding should be at the top of each church's agenda. Safeguarding is about anyone who is vulnerable at any stage, not just children. Infant Oral Mutilation (detailed in the report) is becoming an issue in the UK.

Simon's report was seconded.

Safeguarding training from employment is adequate.

Safeguarding policies protect the vulnerable and the church/organisation. Please take these matters seriously.

It is important to remain vigilant as we return to 'normal' programmes, groups, and activities after lockdown.

Conference accepted the report with no objections or abstentions.

Business Session 1

20. Home Missions and YPD Report

a. Report by Rev Michael Hedley

Each Team Member has been in touch with our churches and the general feel is that majority have returned to almost full capacity. People returned with enthusiasm, and some churches have started new initiatives. Technology played a big role in church's life through COVID, and in some cases it has become an important part of how they do church today.

For some time, we have felt that there is a need for Home Missions to be able to look at ways in which we can better support the Churches in our Union. We need to be able to help to grow and even re-grow healthy Churches. So, we committed to spend some time to look at our YPD provision, sharing resources and prayer networks.

We thought about what youth or children's provision is being offered currently within our churches. Mainly because of Covid much of that provision has disappeared, although there is a return to Sunday Schools, Messy Church, Kids and Toddler groups, there is nothing that can be defined as Youth Provision. The challenge is that in many churches where numbers are low, there is no one to run these events. There have been attempts at sharing resources with other Churches in some areas, but unfortunately these tend to be unsuccessful as other Churches are fighting for the numbers so to speak.

It was suggested that instead of Youth Groups, where the attendees play ping-pong, pool, and other games, and with young people who run amok in some of the church halls, these types of youth groups are no longer viable even if we had the resources. So, the best way, if we have any young people in our Churches, is to involve them in Church life, so that they feel part of it. For example, having our young people running all of our tech provision, such as the cameras, live streaming, sound production, and this works tremendously well as young people are much more aware of tech and not as frightened to give something a try. But our young people can be involved in many other areas such as serving refreshments, welcoming visitors, putting together newsletters, etc. If we can get our young people engaged at this point, they are much more likely to invite friends as they can be seen as doing something positive in the church family.

Another suggestion is to contact Youth for Christ as they offer support with Youth Workers of which there is a charge, but not excessive. They will help to set up youth groups based around the Christian resources that they supply. Thrive is another organisation that can help with this. Michael also is available to help with bid writing to get funding to support the work.

What do churches want and how can we help? Perhaps a lot of Churches would not be able to answer the question as they do not know what they want to do. So, we have split all the Union Churches between the team members of HM and prayed for them. Andy Wilcock has been talking to a lot of the Churches and added prayer points for us to pray for. We will also be contacting the Pastors to ask them what we can pray into for them.

We hope that this will create and encourage a greater sense of interdependence between our Union of Churches, helping to promote good news via various means when there are answers to prayer. We will seek to utilise the Union Website to do this as well as the Contact Magazine.

Other ideas that we discussed were Community Café's and how the Cedarwood Trust has set up a community shop, to help overcome the reliance upon foodbanks. This is where someone pays £4.00 per week to join and then are able to access a food shop, giving them the opportunity to gain societal value by paying for something instead of a handout. Also, Greggs bakers are more than happy to give anything they haven't sold that day that is perishable to Community Café's, that are registered charities.

We can offer support for simple issues like helping to create leaflets for Church's coffee mornings, share board games if they would like to offer a board games afternoon as part of their outreach with refreshments provided by themselves. Joint project working and building relationships between our Union Church leaders is also seen as something that can help with disseminating good news stories, but also offering prayerful and listening support.

For now, our action points are to:

- Set up a HM Team WhatsApp group for prayer support for each other.
- Set up a prayer network where each HM Team Member will receive information on the Churches, they will commit to pray for with their prayer points.
- Contact Greggs for Community Café Provision in the area in which we serve, if that is what your church is doing.
- Contact our local YFC for Youth Support.

Comments:

There is good news out there as was heard during the sharing session last night.

Life Magazine is full of outreach activities and what your area is doing.

Affirmation of the statement regarding finding a new vision for our young people and getting them involved in Church life. We have a generation who really need us.

We need strategy – people who can lead and a discipleship.

Suggested alteration: It was suggested that the reference to Youth Group 'no longer viable' should read 'may no longer be viable. Michael Hedley clarified that he was referring to the pingpong etc based Youth Clubs.

22. Local Preachers' Fellowship Report

Report by Mr D Tuckett

Our last Day of Ministry took place on Saturday 16th October 2021 at Rushden Mission. Our speaker for the event was Ray Evans, who until recently was senior pastor at Grace Community Church in Bedford and is also Church Leadership Consultant for the FIEC.

Ray was recommended by Phil Hearson and stepped in at short notice after our original speaker had to step down due to a change in his role. We also moved the venue to Rushden Mission who were excellent hosts for the event and looked after us very well on the day.

Thanks also to two of our committee members, Cliff Darby who videoed the event and Daphne Hodkinson who without me asking her to, wrote the article in Contact Magazine. It really is a privilege to have the wisdom and support of the LPF Committee!

There were eighteen of us on the day and we had some good discussion times. Ray's subject was "Communication – Passage, People and Prayer."

Ray had very helpfully prepared seven pages of notes including the many quotes he used which saved us taking notes on the day so that we could give him our full attention. The sessions were recorded and are still available in the "links" section of the Union Website together with the 2019 and 2020 Day of Ministry sessions so I would encourage you to view them if you haven't already done so.

Personally, I found this was a wake-up call! What am I preaching – the Gospel or my own ideas loosely linked to a Bible passage? Do the headings challenge or encourage people? Is what I say clear? If I write out my sermon in full it will probably be in "Latinised" English not "Anglo-Saxon" English and will be hard to listen to and understand. What does what I say mean to the hearer? Do I just confirm their "world view" and come over as being superior and smug? Do my PowerPoint slides or other aspects of my preaching distract – much of what people take in is visual not aural. Am I too loud? Too guiet? Too monotonous?

All of these questions challenged me, and I hope that they will improve my preaching and help me to avoid traps which distract from the Good News I'm trying to preach.

I am pleased to announce that **Rev Canon Tim Montgomery** has agreed to be the speaker at our Day of Ministry 2022. This will take place on **Saturday 15th October 2022**. Tim was our speaker at an online conference for Christians Against Poverty last year and I found him both inspiring and challenging.

"Tim Montgomery is Missional Leadership Development Officer in the Diocese of Liverpool, a post he took up after his ground-breaking work as Director of Mission in Wigan. Tim has a background in leading charities and churches through significant change beginning in Cambridge with Romsey Mill and then moving up to Cumbria to help set up The Kepplewray Project. In 2015 Tim moved to Liverpool Diocese to spearhead the 'Transforming Wigan' movement'.

At our committee meeting on Zoom on 22 February we agreed that we would ask Jump Church to host this event. With the new facilities we have at Jump we hope to be able both to record and live stream the event, but we would encourage people to attend on the day as we feel that after the last two years of the pandemic it is more important than ever to meet together.

So please note the date in your diaries and watch out for the publicity and booking details which will follow soon after Conference. We have approached some possible speakers for 2023 and beyond and pray that they will accept the invitation to inspire and encourage us as local preachers.

24. Christian Ethics and Social Action

Report by Mrs D. Hodkinson

I want to begin by thanking you all for your prayers, your encouragement, and your generosity. This committee has considered many issues which make distressing reading, but we believe that God is still on the throne. He is still firmly in control. He is the one who raises up politicians and he will bring them to naught.

My report starts with the war in Ukraine and since the start of Russia's invasion of Ukraine, more than 2.5 million people have fled from their homes. The U.N. has called it the fastest –growing refugee crisis since World War Two, but at the borders in Poland, Romania and Germany, refugees have been met with acts of real kindness. It has been moving to see the lorries being loaded up to the limit with essential items. Also, people from throughout Europe have been giving money, clothing, and food to help these refugees who have nothing except for a small bag with a few belongings in it, but we must pray that these vulnerable refugees do not fall prey to predatory individuals and criminal individuals.

My point is that at a moment of horror and helplessness, we see the response of abundant generosity with people opening up their homes and resources.

Looking closer to home, the CESA committee has been monitoring the consideration of the Conversion therapy and I completed a Consultation document on the subject

One problem is that the Government has tied itself in knots trying to wriggle out of its ill-judged plan to ban conversion therapy. There is no real evidential basis for a ban because "conversion therapy" is a non-issue for most people. BUT it is a VERY big issue for LGBT campaigners who want a ban to criminalise anyone who holds to the Biblical teaching on marriage and sexual ethics. There was a very interesting 24-hour period, starting on the evening of 31st March, when it was leaked that the Prime Minister was planning to drop the ban in the least controversial way, BUT within hours the LGBT activists put enormous pressure on Number 10 and the prime

minister speedily backtracked. So, a ban on conversion therapy remains a government proposal, even though only a small group of politicians feel strongly in favour of it. Is this really democracy?

The next issue was of course "Gender-confused children," and this is going to rumble on for a long time and will cause many problems.

Also, why on earth are we still considering the Assisted Dying debate? Baroness Meacher tried hard to re-introduce this ill-conceived plan, but praise God for the Christians in the House of Lords who stand for God's truth. Many of us contacted our M.P.to reject this proposal. The law should be protecting life!

The Christian Institute is committed to upholding the truths of the Bible which they believe is inerrant. Amen to that.

Many denominations around us are caving into the heresy of same-sex marriage. Let us stand firm on God's truth. Marriage is for one man and one woman.

DayOne continue to publish a wonderful selection of Christian books and Bible notes. They are now selling "Geneva Bible Notes" ... superb daily notes if you are weary of yours. They also provide diaries with Bible verses to hundreds of prisoners each year.

Then many people within the denomination really value the work of "Caring for Life," which celebrated thirty-five years of ministry in February. I know many of you attend the open days. Jonathan Parkinson leads a remarkable team there.

An enthusiastic "Thank you" to all those who have blessed and encouraged us in our work. This has meant that this year we have been able to give £500 to the Christian Institute, £500 To Caring for Life, and £100 to DayOne.
