#### MONDAY, June 9th 2025

#### **Opening Devotions**

Graham Evans proposed the name of Mr George Phillips to Conference, and it was unanimously approved. George responded briefly.

#### 13. Women of Action Report

Report by Mrs S Fall

The Women of Action had a good 2024. Having already started the new teaching series in March at Dorrington Chapel, 'Solid foundation' events also happened at Stoney Middleton in June and Bozeat Chapel in September. We explored God as our Rock and made sure that we were all standing on Jesus as we walk out our faith, and journey through life with all it's waves and storms. There was time for discussion and prayer, and we also shared bread and wine together. The ladies were very responsive and appreciative, and I am still hearing positive comments about the events and what effect they have had on people's lives and churches.

Last year I reported that we had approached some other churches to host events this year, but unfortunately for different reasons there was no progression on these.

We have had several prayer times together on Zoom and one in person in February.

As you know we are always seeking God for the way forward for the WA which has been more poignant as last September I informed the team that I would be stepping down as Co-ordinator and Secretary after the AGM this year. I know that God is calling me to put down these responsibilities as He has other things that He is leading me into outside of the WRU.

I will always be grateful to the ladies of the Women of Action for their friendship, trust and confidence in me. I started to attend the WA meetings in 2001. I became secretary in 2008, was President twice and took on the new role as co-ordinator in 2018. As I look back over my journey I can see how I have grown and have been thoroughly blessed by you all and God. Thank you.

With this in mind we have spent a lot of time praying and discussing what could be next but sadly there has not been a positive outcome. There have been lots of good ideas put forward but God has not laid it on anyone's heart to take up the responsibility of this work.

Therefore, after prayerful consideration over many months it was agreed unanimously at the Annual General Meeting on 26/04/2025 that the Women of Action would close in it's current form. It is hoped that the churches would be encouraged to support the women of their communities as much as possible in their journeys of faith and witness.

This does not mean that the local ladies groups will need to close, but just that there will be no nationally organised events or team. This outcome saddens us all, but who knows what God may raise up in the future.

We are all thankful to have been a part of this incredible work in our time. We also remember all the ladies who have gone before us and the many women around our churches and further afield, who have been blessed by the work of the Women of Action or formerly the Women's Auxiliary.

May God continue to bless you all as you seek to serve Him in and through the WRU.

#### 14. Union Trustees Report & Statistics

Report by Mr George Phillips

The Trustees have met five times during the year. The Administration Manager and Administration Assistant have been invited to the meetings. The ill health of the National Spiritual Coordinator has meant he has not been able to attend any meetings. Michael will leave the role in July when he reaches state pension age, but it is hoped that, if his health allows, he may be able to give support in accreditation of training courses.

The Trustees have continued to consider prayerfully future support and strategy. An overview of statistics shows that, although there have been some small decreases in 2025, most areas (membership, attendance, number of preachers, children and WA) have been relatively stable in the last few years. However, numbers are at a low level, and we recognise many Churches are struggling particularly in terms of leadership resource. As a result of this we are looking at ways the Union can support at Church level with regional leadership coordinators. Andy Wilcock is now working more regionally in the Sheffield, Barnsley and

Derbyshire area and other areas have expressed interest in this approach. There is also a probability of linking with a local organisation to restart the outreach work in the Bierley area of Bradford.

Recently we have completed the transfer of all assets and properties to the Charity Incorporated Organisation (CIO) and the unincorporated charity will shortly be removed from the register.

The property portfolio is increasing by taking ownership of the former Deddington manse. This is taking some time due to solicitor's delays. Significant refurbishment will be necessary before it can be rented. We may also take over ownership of the Bethel Bierley building in Bradford. Rental income from the four current properties in the portfolio has supported Union finances and, therefore, there has been no requirement to increase assessment. The property in Cardwell Avenue, Sheffield is being refurbished which will lead to higher rental value.

The Trustees have been involved in the disposal of several Church buildings.

Over Haddon Lowestoft Smithies Grimesthorpe Chapeltown Ruskington Fen

Many of these have not been straightforward with lost deeds and no property trustees. Grimesthorpe and Smithies sales have been completed recently and progress being made on Lowestoft, Chapeltown and Ruskington Fen.

We have continued to have meetings with other smaller denominations with a Wesleyan background under a move to form a grouping for mutual support called 'Association of Wesleyan Evangelicals (AWE). This has led to a partnership to offer training under the banner of the AWE Academy with Richard Saunders-Hindley as Director. The Theology Course prepared by Geoffrey Lee has been refined and is being delivered by the AWE Academy with Richard Saunders-Hindley and Steven Jenkins as tutors. It is planned to increase the suite of training available starting with delivering Discipleship face to face training in the next year.

The Trustees have performed a management function over the Union employees and continue to monitor the effectiveness of the roles. Grants have continued to be given in support of Churches and monitored by qualitative (reports etc.) and quantitative (measurable statistics etc.) means.

As part of the legal duties time has been given to discuss any changes in investment policies and any issue that may affect the reputation of the Union.

Sandra Fall is leaving the Trustee Board at Conference as she has been led to support Ian in the work of Flame International and we would like to thank her for her contribution over the last three years.

#### 17. Safeguarding Report

Report by Mr S Sykes

Sorry I cannot be with you in person but unfortunately June/July is my busiest time at work. This will not be a long report as there is not a huge amount to say, I continue to get enquiries from churches regarding different topics, mainly covering DBS checks or advice on what paperwork churches need in place. The basic safeguarding training course is now live on the union website but I have not had any feedback from any churches that have used it with their members yet but if anyone has used it either in a group setting or even run the presentation for themselves, please let me know how it went and how you found the course. If you found it useful or if you have any suggestions on anything else that you think could be added to it.

As far as Safeguarding goes there hasn't been any major new updates over the last 12 months. The big emphasis at the moment for all organisations is on The prevent duty and British values including county lines and radicalisation.

As churches we need to be integrating British values and fulfilling our prevent duty obligations all while fostering a safe and inclusive environment. The British values includes, The rule of law, Democracy, Individual Liberty and Mutual respect, they are designed to promote a culture of inclusivity and respect encouraging understanding and tolerance for diverse viewpoints and cultures. We need to highlight the importance of democracy, the rule of law and individual liberty into our daily routines and discussions.

The British values are closely tied in with the Prevent duty regulations that are designed to stop vulnerable people from ending up being radicalised and recruited into gangs or terrorist organisations. We should have a clear understanding and procedures in place for identifying and addressing potential radicalization risks.

We need to make sure our church leaders are equipped with the knowledge and confidence to recognise and respond to signs of radicalization, we need to look for changes in behaviour, increased interest in extremist views or any isolation from peers.

We should be engaging with other relevant agencies to build partnerships and share information.

County lines is the specific act of recruiting young and vulnerable children or adults to transport drugs or other illegal goods around the county. We need to look for signs of individuals being drawn into these criminal networks and provide support for those who may have been affected by county lines exploitation.

I continue as always to be available to assist if churches have any questions or concerns and can be contacted on my email or my mobile number but if you need a more rapid response you are better ringing me as with my current workload it sometimes takes me a while to reply to all my emails.

Take care and continue talking about safeguarding in your churches, the more it becomes part of our everyday life the less daunting it will become and we can better protect the vulnerable individuals we come into contact with on a daily basis.

Home Missions Report

#### Bible Society – A Quiet Revival (taken from the Bible Society Website)

"While some traditional denominations continue to face challenges, we've seen significant, broad-based growth among most expressions of Church – particularly in Roman Catholicism and Pentecostalism. There are now over 2 million more people attending church than there were six years ago.

The Quiet Revival shows that men (13 per cent) are more likely to attend church than women (10 per cent). And as well church decline being reversed, the Church is also becoming more ethnically diverse, with one in five people (19 per cent) coming from an ethnic minority. Close to half of young Black people aged 18–34 (47 per cent) are now attending church at least monthly, according to The Quiet Revival.

It's also great to see that Bible reading and confidence in the Bible have increased as well as church growth. Some 67 per cent of churchgoing Christians read the Bible at least weekly outside church."

This report makes for interesting reading, as does the articles written in response. Earlier this year an anonymous post on a local Facebook community page asked the question "Does anyone know of any good churches in our area?" The following discussion was very informative. We watched as people in our area expressed their opinions on what is a 'Good Church'. What they thought of particular churches in our area, good and bad. Traditions of Christian denomination and sects were also discussed.

As we seek to make Christ known and to communicate the beautiful message of His gospel, it is vital that we understand what questions our society are asking. What the people living around our church are thinking about spiritual matters. Do people even know our church is there and open?

Are we offering the opportunity for people to explore the Christian Faith, Bible and message. Maybe using resources like Alpha, Christianity Explored or 3-2-1.

How are we praying as Churches and believers. Are our prayers informed by a knowledge of the people living in our area, their opinions and experience of spirituality. What challenges are they facing, poverty, materialism, loneliness, fear, guilt, grief, isolation etc.? How is our church alongside other churches looking to connect with people and serve our community?

Our Home Missions Committee would love to hear from you. We'd love to pray with you as a Church. Explore with you how to reach you own area with the great and beautiful message of Jesus and His gospel of hope. We invite new members to join us as a committee to pray with churches, support them in outreach and encourage them to grow in faith, holiness and numerically.

#### 24. Christian Ethics and Social Action

Report by Mr Graham Johnson

As I write this report, I am aware that the Assisted Dying Bill, more correctly called the Terminally III (End of Life) Bill is nearing the report stage in the House of Commons on May 16<sup>th</sup>. This allows all MPs, not just those on the relevant Public Bill Committee, to amend the Bill. They will be able to propose and debate amendments or new clauses and vote on proposed changes to the Bill.

There is still a long way to go with this Bill – it hasn't gone to the House of Lords yet, and there is still time to lobby our MPs to vote against it. There seems to be growing support for the view that the implementation of this bill would undermine the value of human life for some disabled or sick members of the community. We would urge you to pray that this Bill does not succeed and the sanctity of life is preserved.

Employers, schools, Sports Associations and many other organisations are now implementing the gender assignment ruling that came from the Supreme Court. This ruling states that sex is binary. In other words the term 'woman' refers to a biological woman. And facilities such as toilets and changing rooms provided for women can only be used by biological women, not by men, even if they have had gender reassignment.

There is still much confusion and discontent over this but we must continue to pray that the ruling stands.

At the time of writing the Church of England is yet to appoint a new Archbishop of Canterbury. More than 11,000 people, including children, responded to a Public Consultation on the appointment of the new Archbishop. They were able to propose candidates and comment on what they thought the needs of the Church of England are.

The responses will help inform the Canterbury Crown Nominations Commission who will consider the needs of both the Church of England and the wider Anglican Communion. We must pray that the person chosen will be the one God wants.

Finally, we should not forget the various conflicts which are ongoing around the world, for example Ukraine, Gaza and India. You may be aware of others. We continue to pray for peace between nations, and for humanitarian needs to be met.

And we repeat our call for new members to join our committee. If you have a passion for any of the topics featured in this report, or other areas of society where Christian influence is needed, then please consider being a part of CESA. Together we can make a difference.

# MEMORANDUM OF RESOLUTION OF THE MEMBERS OF THE WESLEYAN REFORM UNION OF CHURCHES ("the WRU-CIO")

(a charitable incorporated organisation registered charity number 1203983)

At a meeting of the Annual Conference of the Members of the WRU-CIO on 9th day of June 2025

The members were reminded that:

- The WRU-CIO was registered by the Charity Commission as a charitable incorporated organisation on 13 July 2023
  as the successor charity to a charitable unincorporated association of the same name. The transfer of assets from
  the unincorporated charity to the CIO was completed on 30<sup>th</sup> April 2025
- The WRU-CIO is governed by a Constitution and accompanied by a Union Handbook that sets out how the WRU-CIO will operate.
- The Union Handbook can be amended by a resolution/notice of motion passed by a 75% majority of votes cast at the Annual Conference of the members of the Union. The resolution/notice of motion to be debated at the Annual Conference must be brought to a general meeting held at least six months preceding it.
- The Charity Trustees of the WRU-CIO proposed some minor amendments to the Union Handbook, the details of which were circulated to members of the WRU-CIO and debated at a general meeting held on 19<sup>th</sup> October 2024.

The members RESOLVED to amend the WRU-CIO Union Handbook as follows:

- 1. To add numbering to the heading "Charity Trustees" so that it reads "7. Charity Trustees" and renumber subsequent clauses accordingly.
- 2. To changes references to "Local Preachers Fellowship" to "Equip to Serve" in clauses 5.2 and 8.1 (renumbered as 9.1).
- 3. To add ")" to the end of clause 10.1 (renumbered as 11.1) before ".".
- 4. To delete the words "remove, assist or encourage" from the statement on marriage in the Ethical Statements contained in Appendix C.
- 5. To change the word 'him' to 'them' in the last phrase of the Confession of Faith clause 6 of Appendix A

The members RESOLVED to amend the WRU-CIO Constitution as follows:
